

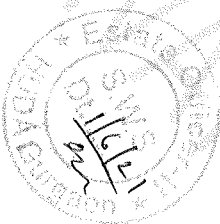
With reference to discussion in the review meeting held on 07.12.2016 attended by your good self-wherein it was suggested to send BPL/EWS patients Monthly report as well.
